



## **EMPIRE STATE PAINT HORSE CLUB FUTURITY**

The ESPHC futurity show will be held in September at the Chemung County Fairgrounds, Elmira, New York. The futurity show will run by the following rules:

**All owners and handlers must be members in good standing of the Empire State Paint Horse Club by the date of the entry.**

All horses must be registered by the American Paint Horse Association **by date of show**. All futurity classes are open to solid paint bred horses along with regular registry horses.

All futurity classes will be run separately from APHA classes. Weanling classes will have free entry into their respective class but are required to pay stall and office fees.

Weanling exhibitor numbers will reflect foaling date.

The weanlings class will be split by age if there are 10 or more entries in the weanling fillies or colt divisions, the classes will be split by the age median.

If there are less than 3 entries in a class, the Futurity Chairman has the right to cancel that class. The entries will then be refunded their money.

**Futurity entry form must be completely filled out with sire and dam's registration numbers. All entries must have a copy of registration papers. Weanling papers can be brought to the show. If weanling is in process of registration, or a transfer is in process, at time of entering futurity, entry must provide the APHA work order number. No transfer papers for transfer of ownership of entry will be accepted, last name on papers will be considered the owner. If nomination forms are not fully completed and turned into the Futurity Chairman prior to the day of your class there will be a late fee charge of \$20.00.**

**All entries must have a valid ESPHC membership (mother club membership only) for owner AND exhibitor or nomination cannot be accepted.**

The futurity chairperson should be notified of change of ownership within two weeks of the sale. Chairperson should also be notified if a yearling colt is to be shown as a gelding by the Wednesday before the show.

**ENTRY FEES:** One payment of \$65.00 for halter and performance is due on or before August 15th. Your forms must be postmarked by **August 15<sup>st</sup>**, or it is considered late. No postal meters accepted. Anything received after this date up until **Sept 15<sup>th</sup> will be \$100.00 and Sept 15<sup>th</sup> before the start of the show will be \$130.00.**

**Payout amounts will be based on number of horses entered, but paid back based on number of entries actually shown.**

**Pay back of money will be awarded on the following percentages:**

1-3	1	100%
4-6	2	60% 40%
7-9	3	50% 30% 20%
10-12	4	48% 28% 16% 8%

16 & OVER	6	40% 24% 14% 10% 7% 5%

Tiebreaker judge will be drawn prior to the start of each class. His placings will be counted twice in the event of a tie between two horses in any futurity class. Money will be paid by taking the total of both placings and dividing it by 2. (Example: Tie for 2nd place- prize money for 2nd and 3rd place will be added together and divided by two. Each entry will receive the same dollar amount.)

A returned check fee of \$25.00 for each time a check is returned for lack of funds.

Substitutions can be made of a horse in the same class by the same owner accompanied by a Veterinarian certificate.

**\*No refunds will be made due to death, injury or illness.\***

Added money for open futurity will be divided up between the numbers of entries **shown** in the futurity.

All judging will be in accordance with APHA rules. Yearling longe line will also run in accordance with APHA rules.

**NEW YORK BRED futurity:** To be eligible for NY Bred Futurity money, the foal must be out of a mare owned by a NYS resident at the time of breeding as shown on the registration papers.

Added money for the New York Bred futurity will be divided between the total of New York Bred entries shown. The entry form must be marked as a New York Bred Horse.
